

**MINUTES FOR THE MEETING OF EASTHOPE, SHIPTON AND STANTON LONG
PARISH COUNCIL HELD ON Thursday 18th September 2014 IN THE VILLAGE HALL

1. **Public Session.** No members of the public were present.
2. **2. Acceptance of Apologies:** Apologies were accepted from Councillors Gibson and Brown. Present Councillors Taylor, Belshaw, Seaward, Jones and Williams. Also present Shropshire Councillor Turner.
3. **Dispensations:** None.
4. **Confirm the minutes of the meeting held on Thursday 17th July 2014.** It was RESOLVED to approve and sign the minutes of the meeting held on Thursday 17th July 2014.
5. **Matters Arising: a.** none.
6. **Shropshire Council Report:** Shropshire Councillor Turner reported that a new university will be opening in Shrewsbury in 2015. The public hearings for the SAMDev document have been set. There is no update on the Wenlock Edge Inn planning application. Councillor Turner is now a member of the Southern Planning Committee, Youth panel scrutiny, Shropshire Hills AONB, Local Joint Committee and deputy portfolio holder for transformation and performance. He holds his next surgery on December 13th.

8. **Roads: a.** Any new problems: The cut through between Bullgate corner and Shipton is now breaking up. There are several potholes on the road between Brockton and Easthope in in Easthope itself. There are concerns about traffic being pushed onto the wrong side of the highway along the road between Easthope and Brockton at the Fishing Pool and down towards the school. Concerns were also raised about parking in Sheinton Street Much Wenlock.
